Cancellation Policy

A refund, minus a \$75 administration fee, will be issued for cancellations received via email to the conference planning committee at RLConvening@intendhealth.org on or before September 8, 2023. No refunds will be issued after September 8, 2023.

As an alternative to cancellation, substitution of registrations is permitted in writing until Wednesday October 4, 2023, by contacting RLConvening@intendhealth.org. Only one substitution is permitted per original registrant. The individual submitting the substitution request is responsible for all financial obligations (any balance due) associated with that substitution, as well as updating any contact information. Exceptions to the transfer policy will be made for registrants who provide proof of a positive COVID-19 test taken within 14 days of the event.

I have read this release, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that by registering for this event, I agree to the aforementioned release freely and voluntarily and intend by my registration to be a complete and unconditional release of all liability to the greatest extent allowed by law.

Waiver of Liability and Indemnity Related to COVID-19
